## **CASE Spring Convocation in Vancouver Well Received**

During the SEI Structures Congress in Vancouver last April, CASE Risk Management Convocation took place. This marked the first time the Convocation was held in conjunction with the Congress. Feedback on the various CASE sessions, including the CASE Dinner with War Stories, was very positive. The CASE Convocation Committee is lining up a great program for the 2009 Structures Congress, which is scheduled for April 30 – May 2 in Austin, Texas.

The next CASE Risk Management Convocation will take place during the ACEC Fall Conference, October 19-22, 2008, at the Fairmont – Queen Elizabeth, Montreal, Quebec, Canada. ## **New CASE Site Visit Cards Available**

Are your people who make site visits confident in the tasks that they are expected to perform while in the field? Do they know what to do before the site visit? Do they know what to bring with them to the field? Are the items to be observed for the particular type of structural system clear and final, and do they know what to do after completing the visit?

Recently CASE Tool No. 10-1: Site Visit Cards, was released. It is the first tool related to the 10<sup>th</sup> Foundation (Construction Administration) of CASE's 10 Foundations of Risk Management. The tool contains sample site visit cards and instructions, which serve as a guide and reminder for the field observer to help minimize oversights and chances for not doing a comprehensive site visit. The cards cover general guidance and rules of thumb for CA and site visits, and structural observations of the following:

Composite Slabs on Metal Deck Reinforced Concrete Flat Slabs Concrete Spread & Wall Footings Reinforced Concrete Masonry Unit Walls Structural Steel – General Framing Wood Framing – Shear Walls

This tool was provided to CASE members free of charge as a member benefit. The CASE Toolkit Committee develops tools to help structural engineering firms focus their practice on avoiding and minimizing risk. These tools are based upon the CASE Foundations for Risk Management shown below. The foundations listed in the left column deal with the process of the engineering business and those listed in the right column address project management.
